## Introduction

### Context

The European Union's Packaging and Packaging Waste Regulation (PPWR) entered into force in February 2025 and will be legally binding from August 2026. It marks a significant step toward a circular economy by setting ambitious goals for reducing packaging waste, enhancing recyclability, and increasing transparency across the supply chain. A key requirement is the Declaration of Conformity, which mandates detailed, standardized information about packaging - data that is currently not collected or exchanged in a standardized manner. To support stakeholders in meeting these complex obligations, Forum Rezyklat has developed this template. It was created through collaboration among a wide range of companies at the national level (e.g. packaging suppliers, producers, licensing partners, solution providers, brand owners, retailers, etc.) and will be further developed at the European level in the next steps. The current template, including all tabs, focuses on Article 5 and Article 11 of the PPWR, as both will enter into force in August 2026. In GDSN – the Global Data Synchronization Network for manufacturers and retailers – the Declaration of Conformity can already be uploaded and shared with retailers or data recipients using existing attributes.

### Aim of the Template

The template serves as a foundation for the technical documentation required to create a Declaration of Conformity. It provides a clear structure for summarizing the necessary data and helps prevent misinterpretations caused by inconsistent definitions and understandings. By consolidating information about individual packaging components into a single document, the template simplifies the process of preparing the Declaration of Conformity.

At the same time, the template functions as a guidance document that supports companies internally in collecting and organizing all necessary data for the technical documentation. In combination with the Supplier Declaration template (as an integral part of the technical documentation), this guidance template ensures that all relevant aspects are considered and helps companies prepare comprehensive and consistent technical documentation.

### Use of the Template

The template is intended for use by any party responsible for declaring packaging compliance, including manufacturers, distributors, and importers. It covers key packaging categories, such as paper, plastic, metal, and glass. Besides, it is suitable for cross-sector applications, including industries such as pharmaceuticals, food, and cosmetics.

### Points to Consider

In the "Guidance Document" tab, the packaging type can be selected in row 7: Sales Packaging (Article 3(5) PPWR), Grouped Packaging (Article 3(6) PPWR), Transport Packaging (Article 3(7) PPWR), or E-commerce Packaging (Article 3(8) PPWR).

Please note that the question on food contact (row 19) applies not only to sales packaging, but also to grouped and transport packaging, provided they come into direct contact with food.

### PPWR and Minimum Standard ZSVR

The recyclability and separability information contained in this document has been established in accordance with Regulation (EU) 2025/40 (PPWR) and the applicable ZSVR Minimum Standard for Determining the Recyclability of Packaging. Component assessments are based on current sorting and recycling practices and consider the influence of individual packaging components on the recyclability of the overall packaging system.
